



Citizen Directed Co-operatives Cymru Working together for independence



Q Citizen Directed Co-operatives Cymru (CDCC) is a new way to help you **take control** of your support requirements.

- Choose **who** delivers your support;
- Decide **where and when** you receive support;
- Have the independence and freedom to choose **how** your requirements are best met, and the peer support to make it happen.

Q What is the Citizen Directed Co-operatives Cymru (CDCC) Project?

We believe that people who receive Community Care Packages from the local authority should have the opportunity to make decisions about the support they receive.

The CDCC Project supports citizens to work together to gain greater choice, voice and control over their support options.

CDCC is a partnership between Disability Wales and Wales Co-operative Centre and is funded by Big Lottery's BIG Innovation fund until March 2018.

Q How will it work?

Citizens eligible for a Community Care Package from their local authority will opt to receive money instead. They will become members of a Direct Payment co-operative which will be jointly owned and managed by its members.

Every member will have a say as to how the co-operative is run.



Members of the co-operative

- Have an equal voice;
- Are able to ask for what they want;
- Are part of a community.

There are lots of benefits to receiving a Community Care Package in this way:

Control

Members have control as they can choose, hire and manage their personal assistant(s). But the admin responsibility that comes with being an employer can be dealt with by the co-operative, instead of the individual.

Social Life

Members can use the co-operative as a way to socialise and take part in activities that they enjoy. Direct Payment recipients are encouraged to use their payments creatively. By joining the co-operative members will be able to explore the possibility of pooling their payments and spending them in innovative ways!

Peer Support

A support service can be offered to help members learn how to work with their personal assistants and make the most of being a member of the co-operative. By working together members will be able to support each other to live independently.
